1. Contracting Partner

The Fraunhofer-Gesellschaft e. V. (referred to as "the organiser") is the organiser of the conference Biological Transformation of Manufacturing. Kontrapunkt Agentur für Kommunikation GmbH issues invoices on behalf of the organiser.

2. Your Consent

I agree to my personal information, gathered for the purposes mentioned above, being collected, processed and transmitted in compliance with the German Federal Data Protection Act (BDSG).

We do not pass on data to third parties or use it in any other way.

By participating, you agree that your data may be saved and processed for the purpose of staging the "FUTURAS IN RES" event. This data will not be passed on to any third parties that are not involved in the organization of the event.

Consent to the use of images and sound recordings:

Please note that during the event photos, videos and sound recordings will be taken by people and service providers commissioned or accredited by Fraunhofer.

By participating, you agree that for the purposes of presenting the event in internal Fraunhofer media and for the purposes of public reporting on the event, you irrevocably relinquish to the Fraunhofer-Gesellschaft all exclusive, assignable, spatially unlimited and temporally unlimited rights for any use or publication of the material, either unchanged or edited, yourself or by third parties. This shall apply irrespective of the transmission, transfer or storage technologies used (notably digital image processing). It shall also apply to video recordings of your speech or your presentation made at the "FUTURAS IN RES" conference as well all photos taken of you at the "FUTURAS IN RES" conference. This consent also applies to editing rights. The citing of names shall be at the discretion of Fraunhofer-Gesellschaft. In this context, you are not entitled to receive remuneration for the photo, video or sound recording taken.

In the case of recordings that focus on individuals, you have the right and the option to inform the photographer or videographer at any time that you do not wish to be photographed or recorded.

3. Conclusion of the contract

The customer's offer for concluding the contract takes place by the correct submission of her/his address and all data necessary for the handling of payments under <https://futuras.fraunhofer-events.de>. Upon submission the customer agrees to these conditions for participation.

The organiser accepts the offer by the transmission of a confirmation e-mail to the customer. Thus, the contract between the customer and the organiser is signed. The payment of the participation fee in full by credit card or via bank transfer is a prerequisite for the customer's participation in the Conference.

4. Cancellation

The participation can only be cancelled in written form.

If the in-box date / postmark date of a written cancellation is before 1st June 2018, no fee is payable. In case of cancellation on 1st June 2018 or later, the participation fee is non-refundable. In this case you will receive the Conference proceedings after the Conference. It is possible to register a substitute participant.

5. Privacy

All data that the customer submits (name, address dates, etc.) as well as the IP address are automatically encrypted during the transmission to <https://futuras.fraunhofer-events.de> and are kept in confidence. Kontrapunkt Agentur für Kommunikation GmbH guarantees that the data are transferred to the organiser. The data are only transferred to the organiser for processing the event.

6. Liability

The organiser is not liable for the actuality, correctness or completeness of the Conference proceedings or the holding of the Conference. The customer accepts that she/he has no claim for damages or any other loss against the organiser (except in case of wilful misconduct) if the Conference is cancelled due to force majeure or for good reason (including, but not limited to, illness of one or more speakers, a low number of participants or financial reasons). The organiser reserves the right to change the programme of the Conference and/or the speakers at the Conference at any time.

7. Place of Jurisdiction

German law applies. Place of performance is Berlin and jurisdiction is Hamburg.
